Many families are wary of in-center services and uncertain about virtual services, which we are offering and continue to improve as teachers learn a new way to teach. Teachers are using Google classroom, Zoom and other virtual teaching avenues. We are loaning tablets and some parents have liked this mode. We are encouraging them to spread the word. We have lost some children to Pre-K, as often happens.
